Normal production time for reorders is 10 business days after we receive a completed Reorder Form. 3. To qualify for original pricing for custom agendas, changes cannot be made. If customer wants changes and/or corrections, the price per agenda will revert to the base price for the quantity ordered. The customer will receive a proof, and the order will not be sent to production until we have received approval from the customer. Errors from inadequate proofing or material inadequately submitted are not the fault of School Mate®. School Mate® cannot be held responsible for changes after the book is in process. Production time will be 30-45 business days (6-9 weeks). 4. School Mate® reserves the right to adjust production schedules due to heavy seasonal demand, shortages, strikes, or any other reasonable causes whatsoever. 5. All orders within the 50 states are shipped FOB destination via UPS or motor freight carrier. AK and HI are extra; call for charges. APO and FPO orders are shipped parcel post; call for charges. Faster delivery service may be requested for an extra charge. If books are returned to School Mate® because no one was available to receive the shipment, or if freight is re-routed, the customer is liable for any additional freight charges. 6.
